The National Brownfields Coalition is the vehicle, the conduit, the connector for selling brownfields to Congress.

***Diverse Support*** - A sampling of our members reveals representation of the varied objectives and sectors that are served by brownfields redevelopment: local government/US Conference of Mayors; sustainability and smart growth/Smart Growth America; economic development/NAIOP; green infrastructure/Trust for Public Land; and community development/LISC. Further, we have involved numerous local governments, non-profits, and state brownfields associations in helping get the message out.

***112<sup>th</sup> Congress*** - With the new Congress there are key opportunities, but also some potential pitfalls. The good news is that brownfields has always been a bi-partisan issue, one of the relatively few areas where Republicans and Democrats have been able to work together. The bad news is that Congress is looking for non-essential programs to cut or even eliminate entirely. With so many new members, congressional education on brownfields is essential.

The Coalition's priorities for the 112<sup>th</sup> Congress are as follows:

- Reauthorization of the EPA Brownfields Program, with a series of program improvements to increase the productivity of the EPA funds;

- Appropriations support for the EPA Brownfields Program, and the HUD BEDI, HUD 108, and Sustainable Community programs;
- Renewal and improvement of the Remediation Tax Expensing Program;
- Improved tie-ins between brownfields and other incentive programs, such as New Markets Tax Credits, and the Energy Department's Clean Energy Loan Guarantee Program.
